The Postal Ballot Notice along with Explanatory Statement under Section 102 of the Act was sent only by electronic mode to those Members whose names appeared in the Register of Members/List of Beneficial Owners as on 03rd March, 2023 ("Cut-off Date"), received from National Securities Depository Limited ("NSDL) and Central Depository Services (India) Limited ("CDSL) and whose e-mail address was registered with the Company / Depositories /Depository Participants A copy of the Postal Ballot Notice is also available on the website of the Company (www.nettlinx.com), the relevant section of the website of the Stock Exchanges on which the Equity Shares of the Company are listed BSE Limited (<u>www.bseindia.com</u>), Metropolitan Stock Exchange of India Limited(cDSL), the remote e-voting service providing agency to the Company (www.evotingindia.com). Members, who held Equity Share(s) of the Company as on 03rd March, 2023, were entitled to vote through remote e voting process in relation to the Resolution specified in the Postal Ballot Notice. The dispatch of the Postal Ballot Notice was completed on 08th day of March, 2023.

4. The Company has appointed "Central Depository Services(India) Limited (CDSL)", as the Agency, for providing the facility of remote e-voting to the Members of the Company CDSL has provided a system for recording the votes of the shareholders electronically.

As stated in Sub-rule 3 of Rule 22 of Companies (Management and Administration) Rules, 2014 as amended from time to time & MCA circulars, on 09th day of March, 2023, public notices were published by the Company in Business Standard (English Newspaper) and in Nava Telangana (Telugu Newspaper) informing about the completion of dispatch of Postal Ballot notices to its shareholders through electronic means, along with all requisite document.

6. In accordance with the MCA Circulars, the physical copies of the Postal Ballot Notice, along with postal ballot forms and pre-paid business envelope, were not sent to anyMember. Accordingly, the communication of the assent and dissent of the Members had taken place through the remote e-voting only.

7. The remote e-voting commenced on 09:00 A.M. on Friday, 10th March, 2023 and ended on 05:00 P.M. on Saturday, 08thApril, 2023 both days inclusive. The remote e-voting facility was provided by Central Depository Services(India) Limited (CDSL).
